### MS. SUSAN REICHLE

*President & Chief Executive Officer, International Youth Foundation (IYF)*

Susan Reichle joined IYF in 2017 as President and Chief Operating Officer. She came to the organization with 25 years of experience leading USAID policy development and programs overseas and in Washington, D.C. In her most recent position, she served as the Counselor to the Agency, USAID's most Senior Foreign Service Officer, and advised the Administrator and senior leadership on key global development policies and management issues. She also oversaw the Agency Coordinators for Youth, Countering Violent Extremism, and Local Solutions while communicating on a regular basis with 80 USAID Missions around the globe.

As Assistant to the Administrator for Policy Planning and Learning, Susan spearheaded USAID policy development, including the agency's first Youth and Development Policy. She oversaw USAID's response to the 2010 Haiti earthquake as Acting Assistant Administrator for Democracy, Conflict, and Humanitarian Assistance (DCHA) in Washington. As Mission Director and Deputy Director in Colombia, Susan led USAID's largest mission in the western hemisphere and worked closely with the Government of Colombia to devise and implement a new strategy to consolidate presence of the Colombian government in conflict and post-conflict zones. In Russia, Susan oversaw one of USAID's largest democracy portfolios in the world, including the agency's first direct human rights program in that country. As one of USAID's first democracy officers, she designed and promoted electoral and democratic reforms in Haiti and Nicaragua. She has a master's degree in National Security Strategies from the National Defense University's War College and master's degrees in International Development Appropriate Technology and Government Administration from the University of Pennsylvania. She is an adjunct professor at Carnegie Mellon University's Heinz College.

### MR. KOFFI ASSOUAN

Koffi manages a portfolio of Youth Learning projects focusing on enterprise development, youth employment, and social and financial education. He has more than 10 years of experience in international development concentrating in organizational administration, project development, implementation and coordination focusing on youth development. Her positions included economist, and managing social sector portfolios, including health, education and environment projects. In Brazil, she initiated a successful public-private partnership, Mais Unidos, which engaged the 50 largest American companies to support social entrepreneurship.

Rosie's twenty-five years' experience in education and skills development has included roles in programme management, research and delivery, from a range of institutional locations, including national ministries, a university, NGOs and development programmes. She has lived and worked in the UK, South Africa, Ghana, the Netherlands, Turkey, and Bangladesh. Her PhD, completed at the Institute of Education, University of London, grew out of research experiences within industrial trade unions in South Africa, and examined how education and training policies were developed, and policy makers' identities were shaped, within shifting constructions of equity and difference over changing political eras in South Africa. He worked as a National Project Coordinator, ILO/ Strengthening Labour Relations in East Africa (SLAREA) in Tanzania from April 2001 to Dec. 2005. In January 2006, he joined the Association of Tanzania Employers (ATE) as Executive Director. He has a vast experience in areas of Labour Laws, International Law, Human Rights and Social Justice, Conciliation and Mediation, and Negotiation Skills. By virtue of his current position at ATE, Dr. Mlimuka is a Member of Labour, Economic and Social Council (LESCO) and a Member of Ministerial Advisory Board of Occupational Safety and Health Authority (OSHA). He was recently appointed as a Councilor to the National Council for Technical Education (NACTE) and a Member of the Regional Steering Committee of the East Africa Skills Transformation and Regional Integration Project (EASTRIP).

Daúdo is a young African leader (32 years old), currently employed as the General Manager of DHL in Mozambique. Originally from Mozambique, Daúdo holds a bachelor's degree in Economics by the University of Algarve (Portugal) and a Master of Business Administration (MBA) earned at the University of Cape Town (South Africa). He started his professional career in Portugal, working in the non-profit sector for the world's largest youth-run organization, AIESEC. Hoping to contribute to the development of his home country, he entered into an entrepreneurial project establishing AIESEC in Mozambique, allowing talented young Mozambicans to discover and explore their leadership potential, offering today international leadership development experiences to thousands of Mozambican youth. He was selected as the Vice President of AIESEC International, responsible for the Africa Region. During his six years in DHL he had a fast track leadership development experience, moving from being the Business Strategy Manager for DHL Sub-Saharan Africa (based in Johannesburg), to being Head of Operation at DHL Angola before moving back to his home country as the Head of Sales. In August 2017 Daúdo became the youngest Country Manager of the Deutsche Post DHL group worldwide. Today, Daudo manages an organization of about 200 people, over 10 Million EUR turnover per year and thousands of shipments and parcels every day, connecting Mozambique to the world and the world to Mozambique. As a corporate leader, Daudo strives on building a culture focus on results and respect towards employees and the society. He has championed several Corporate Social Responsibility projects. His natural leadership skills and his commitment to improving his community led him to become the Curator of the Global Shapers Hub in Maputo, an initiative of the World Economic Forum for which he was selected to speak at the World Economic Forum on Africa in 2017. qualifications/standards and its registration at the National Catalog of Professional Qualifications. In this process, she also supervises the various Sectoral Advisory Committees, composed by the main employers in each professional field, assuring that the qualifications/standards are driven to the demands of the labor market. She has also the responsibility for managing the National Professional Qualifications Framework. In her professional career, she has been Mathematics teacher at Eduardo Mondlane University, for 40 years, which includes a significant experience in teachers' training. Among other positions, she was also the Pedagogical Director of this university for four years.

She has extensive experience in curricula design: she collaborated in the conception of the first National Education System, in several curricular reforms carried out at the above-mentioned University and in the ongoing Vocational/Professional Education Reform, whose implementation is regulated by ANEP.
